- d. NOC/NDC from the concerned bank/financial institution/Industrial development corporation/an undertaking (attested by the Magistrate) stating that any liability arising due to change of constitution shall be borne by the proprietor/Partner/Company
- e. NOC from the State GST Department/PDD

f. Any other additional document(s) deemed necessary by the Directorates to support the peculiarities related to a case
